



## **Grant Awards for WRJ's Sisterhood Leadership Conference**

Women of Reform Judaism is awarding grants to help sisterhoods send current as well as “up and coming” sisterhood leaders to WRJ's Sisterhood Leadership Conference in New Orleans, January 23-25, 2009. Sisterhoods selected to receive a grant will be awarded the **\$250 registration fee** for the conference, which covers programming, materials, and all meals.

The purpose of the WRJ Grant Awards is to enable sisterhoods that have not attended leadership conferences in the recent past to join us at the conference in New Orleans. **Your sisterhood is eligible to apply for a grant award for the leadership conference in New Orleans**, since your sisterhood was not represented at either of the last two conferences (Tyson's Corner and Atlanta).

**Applications must be received at the WRJ office no later than Monday, October 13, 2008.** Receipt of the application will be acknowledged by e-mail.

Notification of grant awards will be sent via email by Friday, October 24, 2008.

Sisterhoods that receive a grant must notify WRJ of the name of the woman who will be using the grant by Friday, November 7, 2008. (Sisterhoods will receive the reimbursement for the registration fee shortly after the conference.)
